Subj: EMERGENCY OPERATIONS CENTER DIRECTIVE 20-003G DECREASING  
HEALTH PROTECTION CONDITION LEVEL TO BRAVO

1. The Joint Base Pearl Harbor-Hickam (JBPHH) Commander has decreased the Health Protection Condition (HPCON) level to HPCON BRAVO. At this time, the COVID-19 transmission risk has decreased, but not disappeared. Continue to make smart decisions and maintain disciplined compliance with health protection measures to further reduce virus transmission risk.
2. With this announcement of HPCON BRAVO, avoid unnecessary contact with others. Avoid unnecessary travel to areas known to be experiencing active disease transmission. Monitor and comply with travel restrictions and mitigations in place for public gatherings, such as schools, religious services, and other community activities. Observe local guidance on movement restrictions and access requirements for military installations. Seek guidance from employers and unit leaders about changes to work practices. Comply with medical orders for self-isolation or quarantine.
3. Follow DoD and local higher headquarters guidance, as well as Centers for Disease Control and Prevention recommendations for mask use. Individual tenants and base services may be more restrictive in mask wear policy, especially in high risk locations. Please continue to follow city and state guidance when off installation.
4. Guidance for on-installation and off-installation activities.
  - a. Personnel may visit, patronize, or engage in the use of all facilities and services that are open onboard the installation. Exchanges, commissaries, gas stations, base-affiliated restaurants and mini-marts located off-installation are considered "on-installation" for the purpose of this directive.



b. Personnel are authorized to engage in indoor or outdoor recreational/social gatherings in compliance with local State of Hawaii regulations. Personnel are not authorized to engage in gatherings of any size where anyone present is symptomatic with an influenza-like illness or is known to be COVID-19 positive.

5. Hawaii-based Joint Base Pearl Harbor-Hickam civilians, contractors, and family members are expected to exercise personal responsibility and are highly encouraged to comply with the above off- and on-installation measures.

6. Post HPCON LEVEL BRAVO, enclosure (1), to all building entrances onboard JBPHH.

## Health Protection Condition (HPCON) Levels

### HPCON LEVEL BRAVO

#### Moderate

- Avoid unnecessary contact with others, such as shaking hands and hugging
- Avoid unnecessary travel to areas known to be experiencing active disease transmission
- Monitor travel restrictions and mitigations in place for public gatherings; make alternative arrangements for childcare
- Seek guidance from employers about changes to work practices, work occupancy levels, and training events
- Comply with medical orders for self-isolation or quarantine
