

# VEHICLE REGISTRATION AND LICENSING FOR MILITARY PERSONNEL

13 APRIL 2020

## DRIVERS LICENSE:

All drivers licensing centers and Satellite City Halls are closed to the public until further notice. If your license expires anytime between 15 March – 15 May, 2020, it is automatically covered by a 90 day extension. If you lose you license during the COVID-19 pandemic, you can request a new license online at <a href="https://www1.honolulu.gov/duplicates">https://www1.honolulu.gov/duplicates</a> or call (808) 768-9100.

### **VEHICLE SAFETY INSPECTION:**

- Safety check stations are closed. If your safety check is expired, it will remain valid through 31 May.

### **VEHICLE REGISTRATION (HONOLULU, HAWAII):**

- All Satellite City Halls are closed for in-person visits, but City staff continue to work on requests submitted through mail, online (www.hiplates.com), or via self-service kiosk (Safeway and other).
- For military members wishing to register vehicles using a tax exempt form, please adhere to the following:
  - Forms can be obtained from your military personnel unit, unit admin, or unit S-1.
  - Hawaii residents on active duty and members of the National Guard and Reservist and who are assigned to units in Hawaii are authorized to use one CSL (MVR) 50A form for a vehicle registered in their name.

#### Mail in the following:

- Completed CSL50 (non-resident) or CSL50A (resident)
  \*please ensure to inlcude your DoD ID number
- Certificate of registration or motor vehicle renewal notice

- Call (808) 768-4324 or email <u>MVREG@honolulu.gov</u> for Out-of-State Registration application.
- Application and instructions of how to proceed will be mailed to you.

NOTE: Vehicles can still be registered with an expired safety inspection. HPD will not cite you for expired safety inspections. Expired safety inspections will be valid through 31 May 2020. HPD **will** continue to cite for an expired registration.
